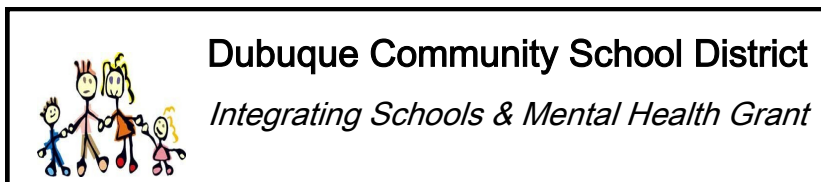
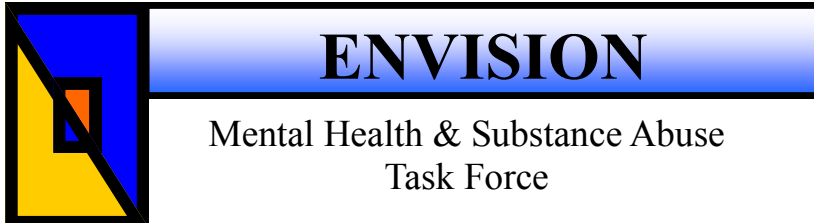

Serves Adults Ages 16 & Older. Under the Habilitation Waiver, provides home based services and supported employment that includes job coaching and group enclave settings. Home based habilitation helps develop the skills needed for community living. The services are intended to provide for the daily living needs appropriate for the individual. These skills include: adaptive skill development; community inclusion; transportation; adult education supports; social /leisure skill development; personal care; protective oversight; and supervision.

- Supported Employment Habilitation provides help finding employment for individuals with disabilities and is designed to assist members in obtaining and maintaining employment. Services include: initial vocational and educational assessment; job development; on-site vocational assessment, disability related support or vocational training, assistance in learning specific job skills; including transportation for job exploration.
- Services provided to maintain employment include: individual work-related behavioral management; job coaching; on-the-job work-related crisis intervention; assistance with skills related to maintaining competitive employment; assistance with time management; assistance with appropriate grooming; employment-related supportive contacts; on-site vocational assessment; and employer consultation.

tracted service contracts, United Way contributions, and other donations.

- Iowa residents are eligible for reduced fees based on income and family size. No Iowa resident is refused services based solely on an inability to pay.
- Out-of-state residents are eligible for services at full fees. Those out-of-state residents needing subsidized services are referred to programs in their states.
- Health insurances and Medicaid (Title XIX) accepted.

Current programs and services provided include:

1. **Assessments for addictive disorders** including alcohol and other drug addictions, problem gambling, and co dependency for all ages.
2. **OWI assessments** for all arrested for drunk driving.
3. **Outpatient Treatment** including individual, family, and group counseling components for all ages.
4. **High Risk Youth Programming** including on campus counseling services at Dubuque Middle and High Schools, Beckman High School & the office based Early Intervention Program for adolescents.
5. **Alcohol Diversion Programming** for those ages of 18 - 21 who are arrested for alcohol possession under the legal age.
6. **Marijuana Diversion Programming** for those under the age of 18 who are arrested for marijuana possession and/or possession of drug paraphernalia.
7. **Prevention programming**, which includes community outreach and educational components – all ages and groups.
8. **OWI Offender Treatment Programs** in conjunction with the Iowa Department of Correctional Services – corrections clients only.
9. **Driving Unimpaired Classes** for drunk drivers – all ages.
10. **Gambling Treatment Program** that provides a full continuum of prevention and treatment services for those experiencing problems due to legalized gambling for all ages.

How to Access Services: Drop-in initial screenings with no appointment Mon-Thurs 9-4 and Fri 9-12 or call 563-584-3784 for more information. Bring proof of income, insurance card, Medicaid (Title 19) card. Legal papers required if coming to SASC due to a legal charge.

Serves Adolescents, Adults and Families. Substance Abuse Services Center (SASC) was organized in 1975 for the purpose of reducing the incidence of, and problems relating to, addictions in Dubuque and Delaware Counties. SASC is a not-for-profit agency governed by a volunteer Board of Directors comprised of citizens of Dubuque and Delaware Counties. It is licensed as both a substance abuse treatment facility and a problem gambling treatment facility by the Iowa Department of Public Health. SASC maintains full-time offices in Dubuque and Manchester. A self-assessment is completed by the individual to determine which role the individual is most interested in developing. Once this is chosen, the consumer-driven process begins lasting anywhere from six months to two years. There are four phases of the process: Readiness Development, Goal Setting, Goal Achieving, and Goal Keeping. Individuals meet with their practitioners between 4 and 10 hours a week. Participants will gain new skills and supports that will help speed their recovery in the area they have chosen.

These children exhibit severe behaviors usually treated in an out-of-home placement. Children must be diagnosed with a serious emotional disturbance (SED). The waiver brings together a team directed by the child and their parents to create a plan based on the child’s needs. The family and the Targeted Case Manager (TCM) determine what services would benefit the child. Those services include in home family therapy, family and community support services, and respite services. In the event the family could not afford home and vehicle modification, it is possible that the Child Mental Health Waiver would cover this.

The Child Mental Health Waiver is for children who have a DSM –IV Mental Health Diagnosis and the child’s behavior warrants possibly being placed outside the home. If the child’s primary diagnosis is Autism or Asperger’s Disorder the child does not qualify for services. The family is encouraged to call if they have questions about this. The Child’s Mental Health Waiver is based on the family’s income.

Serves Adolescents. We offer four Residential Education programs on our campus in Dubuque:

New Hope is a specialized residential education program for adolescent male sexual offenders ages of 12-17 years old. We offer intense structure & groups specifically addressing the offending issues. We also work on the client's own victimization issues.

Pathways is a co-ed specialized residential education program for low functioning adolescents ages of 9-17 years old. We offer a Tru-thought curriculum that is designed to work at a reading level that works with the lower functioning so they can comprehend & make the desired changes needed to become productive citizens in our communities.

New Pathways is a specialized residential education program for low functioning adolescent males ages 12-17 years old offering a Tru-thought model curriculum that is designed to work at a reading level

Serves Adults. Provides assessment, referrals, arrangement of funding for mental health services, and monitoring using a team approach. This is a voluntary service based on respecting consumer choice of services. To qualify for services an individual needs to be an adult with severe and persistent mental illness with Medicaid (Title 19) Eligibility. Habilitation Services is a program to provide Home and Community Based Services (HCBS) to individuals with functional deficits typically associated with chronic mental illness. Case Management is required to access Habilitation Services. Services which Case Management will arrange, monitor, and arrange funding for include the following:

- Case Management Home-Based Habilitation Services provided in the person's home and community. Typical examples would be assistance with medication management, budgeting, grocery shopping, etc.
- Day Habilitation is usually provided in a day program setting outside the home. Focuses on areas such as social skills, communication skills, and behavior management.
- Prevocational can be provided in a variety of settings, focuses on developing generalized skills that prepare a person for employment. Typical examples include attendance, safety skills, following directions, and staying on task.
- Supported Employment assists in obtaining and keeping a job in the community. Typical examples would include: skills assessments, consultation with the employer, job coaching, and behavior management.

They learn anger management, conflict resolution, impulse control, relationship building, and employment-related skills. The iCan staff includes a team of college level counselors.

How to Access Services:

Paperwork can be filled out on the second floor of the Dubuque County Courthouse at the Clerk of Court's office. There needs to be two adults willing to sign the required application who clearly list behaviors that are of concern. Once the application is completed, a judge will review the information and determine if sufficient grounds exist to

Peterson is a residential education program for adolescent males from the ages of 12-17 years old. This program offers a curriculum that includes the Equip Program anger replacement and social skills groups as well as the Tru-thought model corrective thinking groups and curriculum.

Hillcrest Family Services-School Based Youth Services (SBYS) Program

Serves Children and Adolescents in participating schools. Master's level counselors provide on-site mental health services that include: mental health assessment, individual and group therapy; family support; case coordination services; educational services & crisis management. This on-site program offers students and their families help navigating access to mental health services.

ors provide skill building and training in all areas of daily life, including: decision making, money management, community independent living skills, time management, coping skills, developing and maintaining a daily routine, medication and illness education, developing community resources and supports and scheduling and attending appointments.
